CSQ Funding

Construction Skills Queensland (CSQ) Funding

CSQ is an independent, not-for-profit, industryfunded body supporting employers, workers, apprentices, trainees and career seekers in the building and construction industry.

If you are currently working in the Queensland building and construction industries and want to further develop your skills, you may be eligible for CSQ funding towards the cost of your training.







CSQ Eligibility Criteria

I AM

- Employed in Queensland within the building and construction industry OR an unemployed eligible worker (unemployed for less than 4 years).
- An Australian or New Zealand Citizen, Permanent Resident or a Visa holder with relevant permission to work (excluding international student visas).

I AM NOT

- An employee of any Authority (local councils acceptable if meet eligible worker criteria).
- Funded by an Authority or such other source for delivery of the same training being undertaken as part of this program.
- Currently enrolled and participating in a school program (excluding eligible school-based apprenticeships and trainees).
- A contracted trainer and assessor or an existing worker of any RTO.
- Seeking a Verification of Competency

If you meet all of these criteria, we encourage you to speak with our team to find out what funding support may be available for you.

This course equips you with the skills and knowledge required to perform dogging safely and efficiently and focuses on working alongside cranes, engaging slinging techniques, selecting and inspecting lifting equipment and directing crane operators in the movement of loads.

Licence to perform rigging (basic level) - CPCCLRG3001

A rigger is responsible for the safe movement of plant and equipment, both static and moving, on a work site. A basic rigging licence is required for those who are undertaking work where decisions regarding slinging techniques are required.

Licence to perform rigging (intermediate level) – CPCCLRG3002

Riggers use mechanical load-shifting equipment to move, place or secure loads, including plant, equipment or members of a building or structure. This course focuses on more advanced rigging techniques involving cranes, conveyors, dredges, excavators, tilt slabs, demolition, and dual lifts.



Licence to erect, alter and dismantle scaffolding (basic) – CPCCLSF2001

This course equips you with the skills and knowledge required to perform basic scaffolding tasks safely and efficiently. The course focuses on erecting, altering, or dismantling a temporary structure to support a platform from which a person or object could fall more than four metres.


This course builds on the skills and knowledge learned in the basic course and focuses on the planning and preparation, erecting, altering, and dismantling of various scaffolding types. These include cantilevered platforms, spurred scaffolds, barrow ramps, safety screens, mast climbers, and tube and coupler scaffolds.

Entry requirements - Participants must have successfully completed the unit CPCCLSF2001 Licence to erect, alter and dismantle scaffolding basic level





Licence to operate non-slewing mobile crane (greater than 3 tonne capacity) - TLILIC0040

A non-slewing crane, or franna, is a crane that can lift loads, has a boom, but does not have a rotating base section to rotate the load. This course equips you with the skills and knowledge required to conduct non-slewing crane operations including lifting loads, positioning, travelling and performing multiple crane lifts.

Licence to operate a slewing mobile crane (C1) up to 100 tonne - TLILIC0021

A slewing crane is a crane that lifts loads, suspends that load in mid-air, and can change the direction of the load by rotating it side to side via a boom mechanism. This course equips you with the skills and knowledge required to safely conduct slewing crane operations, including lifting loads, travelling cranes, and performing multiple crane lifts.

Conduct telescopic materials handler operations - RIIHAN309F

A telescopic handler (often called a telehandler) is a hydraulic lifting machine used to carry and place heavy materials. This course equips participants with the knowledge and skills required to conduct telescopic material handler operations and applies to those who work in operational roles across numerous industries.

Perform Rescue from a Live LV Panel Cluster - LVR007

This short course is designed to give participants the skills and knowledge to perform rescue from live low voltage electrical apparatus in an electrical services industry environment, not including overhead lines and underground cables in the workplace. It is suitable for people employed as electricians and others employed in the electrical services industry.
